Carbondale | Murphysboro

This route connects Carbondale and Murphysboro. In Carbondale, transfers can be made to the Saluki Express network at major transfer hubs, including the SIU Student Center and the Southern Illinois Multimodal Station (SIMMS). In Murphysboro, it connects the newly established, JAXFlex microtransit service at the Jackson County Courthouse.
